# **Texas Groundwater Protection Committee**

### **Protecting One of Our Most Precious Resources**

#### **OVER 30 YEARS OF PROGRESS**

The Texas Groundwater Protection Committee (TGPC) strives to identify areas where new or existing groundwater programs could be enhanced, as well as to improve coordination among agencies involved in groundwater activities. Created by the Texas Legislature in 1989, the TGPC is a coordinating mechanism for nine state agencies and the Texas Alliance of Groundwater Districts. TGPC members are as follows:



- The Executive Director of the Texas Commission on Environmental Quality (TCEQ) Chair
- The Executive Administrator of the Texas Water Development Board (TWDB) Vice Chair
- The Executive Director of the Railroad Commission of Texas (RRC)
- The Commissioner of the Texas Department of State Health Services (DSHS)
- The Deputy Commissioner of the Texas Department of Agriculture (TDA)
- The Executive Director of the Texas State Soil and Water Conservation Board (TSSWCB)
- A representative selected by the Texas Alliance of Groundwater Districts (TAGD)
- The Director of Texas A&M AgriLife Research (AgriLife Research)
- The Director of the Bureau of Economic Geology of The University of Texas at Austin (UTBEG)
- A representative of the Water Well Drillers and Pump Installers program at the Texas Department of Licensing and Regulation (TDLR)

## **ENABLING LEGISLATION**

The TGPC's enabling legislation (House Bill 1458, 71st Legislature) allows the various state agency heads to designate personal representatives to conduct the business of the TGPC, and since 1989, those representatives have ensured that the major responsibilities of the TGPC have been carried out, including:

- Developing and updating a comprehensive <u>Texas Groundwater Protection Strategy</u><sup>1</sup>;
- Studying and recommending to the <u>Legislature</u><sup>2</sup> groundwater protection programs for each area in which groundwater is not protected by current regulation; and,
- Publishing a <u>report</u><sup>3</sup> documenting the status of groundwater contamination cases and groundwater monitoring programs.
